Treasurers Report:

- \$6,000 currently confirmed in sponsorships/support for Multicultural Festival
- Request sent to town for first installment of core funding
- With no current plans to expand on events for this year, contracted labour costs may be lower
- Budget received from Devour! for Kentville event: Preliminary budget of \$16,900; reworked to tentative budget of \$13,800
- Reworked KBC budget is now running an approximate deficit of \$14,000

Façade Program:

- Discussed request from a façade program applicant to change application to a different building for a project that had already been completed, request was not granted
- Mural Project at Main street Station complete and paid out. Cost came in under budget

Events Committee:

- Planning for Multicultural Festival is going smoothly, gathering sponsorships and funding has been more difficult this year
- Spring Into Kentville is nearly complete
- Festival of flowers will have a renewed push this year, with more public engagement, public will vote for favourite floral displays
- Grant from Nova Scotia for \$5,000 was not successful for Multicultural Festival, contacting to get an explanation



- Mud Creek Rotary wants their funding to go towards vendor fees, which will not help the event raise funds
- Discussed ways to raise more funds in different ways to pay for event, such as upping the rate for vendors but to late for this year

Executive Director Report:

- Mural project at Main Street Station was a resounding success, created a video to showcase the mural and it being completed which was posted to Facebook
 - o Over 23,000 reached
 - o 3,300 Engagements
 - o 203 Shares
 - o 11,000+ Views
- Social Media pages have seen continued growth, now surpassing 1,300
 Facebook Likes & Followers
- Follow up meeting regarding Circus Circle and how KBC may contribute
- Discussed work on Spring into Kentville and Festival of Flowers
- Discussed concerns raised regrading burnout competition during Devil's Half Acre Motorcycle Rally, and issues with vendors disturbing businesses during Apple Blossom
- Discussed upcoming Juniorpreneur Camp put on by CEED
