What is a BIA?

A Business Improvement Area (BIA) or Business Improvement District (BID) is an association of commercial property owners and tenants within a defined area who work in partnership with the Town to create thriving, competitive, and safe business areas that attract shoppers, diners, tourists, and new businesses.

BIAs improve their local economies through activities such as:

- Promotion of shops and services
- Hosting festivals and events that draw people to the downtown area
- Safety and security initiatives
- Beautification efforts and façade improvements
- Strategic plans for business recruitment and infrastructure projects
- Providing opportunities for networking and collaboration
- Advocate on behalf of their membership as a collective voice



Where does the funding come from?

Kentville Business Community develops a budget, which is then approved by the Town of Kentville, and collected through an economic development levy. KBC also applies for grants from other regional economic development agencies and provincial and federal granting bodies.



Where does the funding go?

The bulk of KBC's funding goes into beautification and facade grants to improve the look of our downtown.

A large portion of the budget is also dedicated to running marketing campaigns, promotional activities, and events to attract people to visit, shop, and do business in Kentville.

Did you know: KBC is the only BIA in the Annapolis Valley that is a member of Downtowns Atlantic Canada? This gives us access to provincial information and opportunities.
